
## Jaffrey Chamber of Commerce Awarded ARPA Funds


Cheshire County Commissioners and County Delegation made up of 23 State Representatives awarded the Jaffrey Chamber of Commerce \$20,000 dollars from the funding received through the American Rescue Plan Act (ARPA).

Cheshire County was awarded over 14 million dollars through ARPA in June of 2021, and after looking internally at how they could best utilize this funding, the commissioners and County Delegation looked to the community to see how best we could have the most impact. The County looked at those small businesses and non-profits that serve our communities' health and well-being and fiscal recovery from the COVID Pandemic. The county has given to date over 3 million dollars of ARPA Funding back to our local organizations and firms in Cheshire County.

Chris Coates, the County Administrator leading the Delegation, said "The Jaffrey Chamber of Commerce serves as a valuable resource to the business of Jaffrey and the surrounding area; they also advocate for a strong connection between businesses and the local community by hosting and communicating about community meetings and events. ## What should you know about IRA rollovers?

If you've been contributing to an IRA, you've chosen a great way to save and invest for retirement. All IRAs have potential tax benefits and a range of investment possibilities, but not all IRA providers offer the same features. So, if you decide that your current IRA provider is charging higher fees than you'd like, or perhaps doesn't offer as many investment choices as you want, then you might choose to move your IRA assets to another provider. How should you go about making this switch?

Here are some options to consider:

- Trustee-to-trustee transfer or direct rollover You can ask the financial institution holding your IRA to move the money directly to another IRA. No taxes will be withheld from the amount transferred at the time of the transfer. This method is generally hassle-free, but some IRA sponsors will still only mail the check to your address of record, so you'd have to forward it to your new IRA.
- Indirect rollover If you take an indirect rollover, also known as a 60-day rollover, the assets from your existing IRA will be liquidated and the custodian or plan sponsor will send you a check or deposit the funds directly into your bank or brokerage account. This payment may be subject to withholding for federal taxes, and possibly

state taxes, unless you opt out of withholding. You have 60 calendar days from the time the funds were withdrawn to deposit the money, including any amount withheld, into a new IRA. If you miss this 60-day deadline, the withdrawal may be taxable at your personal income tax rate, and it could also be subject to an early withdrawal penalty if you're younger than 59 1/2.

Given the immediate withholding and the possibility of further taxes if you don't move the money into a new IRA before the 60 days are up, you've got much to consider before initiating an indirect rollover. Consequently, you should consult with a financial advisor and tax professional before you make this type of move.

In addition to a rollover from an existing IRA, you may someday want to move the money from your 401(k) or similar employer-sponsored retirement plan to an IRA. This can occur when you retire or change jobs, although if you do take on another job, you might have the options of leaving your 401(k) with your former employer or rolling it over into your new employer's plan. However, if you do want to move your 401(k) funds into an IRA, you can make what's known as a direct rollover, in which the administrator of your old retirement plan will send you a check made payable to the custodian of your

IRA. No taxes will be withheld, but you need to get the funds transferred within 60 days to avoid any potential tax issues.



## Jaffrey-Rindge Cooperative School District and Franklin Pierce University Partner To Train Next Generation of Teachers

This partnership will provide hands-on training for FPU students and additional opportunities to personalize education at JRCSD.





The Jaffrey-Rindge Cooperative School District (JRCSD) and Franklin Pierce University have announced a formal partnership to provide undergraduate students with hands-on, real-world classroom training in preparation for the job market or graduate study.

"A consistent presence of Franklin Pierce students in our classrooms and facilities will benefit our learners, staff, and the broader district community by increasing our ability to personalize education for our Jaffrey and Rindge learners," said JRCSD Superintendent Reuben Duncan. "This partnership gives Franklin Pierce students access to a welcoming and collaborative environment that will surely help their transition from students into the next generation of teachers and educational leaders."

The partnership will allow students seeking certification in elementary, secondary, or special education the option of clinical placements throughout the JRCSD, from kindergarten to twelfth grade. By gaining this experience, Franklin Pierce students will be better prepared to manage their own classrooms prior to a minimum of one semester of student teaching, which may also take place in a IRCSD classroom.

"The partnership between Franklin Pierce and the Jaffrey-Rindge Cooperative School District is the epitome of experiential learning," said Joan Swanson, director of the University's School of Education. "With this memorandum of understanding, we are solidifying an already robust partnership that

will undoubtedly build instructional capacity and educational leadership throughout the greater Monadnock region."

Select Franklin Pierce education courses have been taught at Rindge Memorial School and the Jaffrey-Rindge Middle School since August 30. This structure allows students to seamlessly switch between their undergraduate classes and observation hours, and also enables them to have parttime volunteer or employment opportunities.

"Our hope is that by having our students in the classrooms, it will create more personalized instruction for the K-12 learners," added Swanson.

Franklin Pierce students may also have an opportunity to transition into a job within the district after graduation, giving the JRCSD new employees that already have experience within the school community.

"As we continue to enhance our partnership with Franklin Pierce throughout this school year and in the years to come, their students will benefit from our teachers' expertise, and our district will increase its capacity for hiring and retaining great teachers," noted Duncan. "Our existing staff also stand to benefit from this relationship as they will have access to increased leadership opportunities when

working with Franklin Pierce students."




## Four-Legged Friends Scared of Loud Noises? Here Are Some Tips

The Fourth of July is over, so you can breathe a sigh of relief and put fireworks out of your mind until next year, right? Wrong! Right now is the best time to start working on desensitizing your dogs for next year. Some dogs who have fireworks phobia also have thunderstorm phobia. Why not take some time and invest in your dog's future comfort now?

Many of us rely strongly on management to get our dogs through these acute events, calling our vets in a panic for medication, setting up specialized rooms with sound buffers, throwing on thundershirts, and holding our shaking dogs while we pray for our neighbors to stop with their backyard fireworks displays. While some of these options can be helpful





in the moment, and for some dogs will always be a necessity, there are simple steps we can take to help acclimate them to these stressors so that we aren't sent into panic mode next July, or any time a summer thunderstorm is predicted on our weather app.

Systematic desensitization can be as simple as playing realistic sounds of fireworks and or thunderstorms, at a low volume that the dog can tolerate without stress. Thanks to youtube and white noise apps, these sounds are easy to access for everyone. You can pair these sounds with high-value food such as cheese, chicken or hot dogs, and relaxation exercises such as settling on a mat. Increase the volume slowly over time in increments that your dog can remain calm through.

If you find yourself caught in a sudden thunderstorm or with inconsiderate neighbors setting off fireworks on a random day, and your dog's stress level is mild enough, you can simply shower them in treats or kibble. This can help build up Classical Conditioning between the sounds they are hearing and the appearance of something they like, food! If you put the work in with getting them accustomed to these sounds, when an event sneaks up on you, you will be

prepared to handle it, and your dog will be much calmer.

For new puppies, and dogs that don't yet have any association between these noises and anxiety or fear, start early, pairing the sounds with food or play. Set them up to succeed when it comes to these scenarios as they mature. Thunderstorms mean tug or fetch; make treats rain from above as lightning streaks across the sky.

While many of us are reactionary when it comes to noise phobia with our dogs, it can pay off today, tomorrow, and for years to come if we set aside the time to make our dogs' lives better when they aren't stressed and panicking. Let's be honest, it will make our lives better too. Why wait? ## **Boy Scouting in Jaffrey: A Vibrant and Valuable Experience**

The Boy Scout Movement was founded in Great Britain in 1908 by the then Lieutenant General Robert S.S. Baden-Powell. He had no idea how popular his idea would become around the world. His goal was to develop good citizenship, chivalrous behavior and skill in various outdoor activities in boys ages 11-14. In 1916 the age group was expanded to include both younger down to 6 yrs. of age and older boys up to the age of 18.

It was Feb. 1910 when scouting arrived in the United States. Wm D. Boyce, an American businessman and millionaire, incorporated and funded Boy Scouts of America and appointed a permanent executive. He had picked up Baden-Powell's book, "Scouting for Boys" when traveling in England and was inspired by it.

Scouting came to Jaffrey in 1940 when Hubert O'Neill became the first Scoutmaster for Boy Scout Troop 33. Twenty-one Scoutmasters have since led the troop. It is impossible to count the number of Jaffrey boys who have benefited from the guidance of these dedicated adults.

Eagle Scout is the highest achievement or rank attainable in the scout program and Troop 33 has had 26 boys who have achieved this rank!

In the words of Eagle Scout Kris Houghton, "I had a wonderful experience being a part of Boy Scouts in Jaffrey in the late 1980s. We had a large active troop with a nice mix of experienced older scouts and younger members. Through monthly camping trips we learned how to plan menus, shop for food and cook in the outdoors. To achieve the rank of Eagle Scout, each candidate must plan, raise money and execute a project that helps the community. My project was a playground behind the United Church that included clearing brush, building a
